The Issuer's gaming and casino revenues throughout Central and Latin America continued to meet management's expectations in the month of January 2007. The Panama operations, of which the Issuer owns 50%,



posted revenue of \$4,377,000; in Guatemala the operations generated revenue of \$520,000; in Nicaragua the three operating casinos of which the Issuer owns 52.6% generated \$1,135,000; and in Costa Rica, of which the Issuer owns 50%, the operation generated \$1,945,000 of revenue. The Issuer's Eastbay Resort and Poro Point casinos in the Philippines where the Issuer controls 60% and 65% of the operations respectively, generated revenue of \$2,462,000.
